President Obama's Executive Action on Immigration

On November 20, 2014, President Obama announced that some immigrants without status may qualify for "deferred action" which will allow them to apply for temporary 3-year work permits. This process will not start for a few months. Find out if you qualify, and what you should do next...

Who qualifies? What steps Gather documents to see if you qualify for the program:
• Proof that you were in the U.S. on November 20, 2014. If you haven't
now? already, get proof that you were in the U.S. on this day. For example, a
bank statement, records from a doctor's office, or other proof.
Proof of Relationship to U.S. citizen or lawful permanent resident children:
Birth Certificate of son or daughter, or other proof.
Proof that your son or daughter is a U.S. citizen or lawful permanent
resident: Passport, Birth Certificate, Naturalization Certificate, Lawful
Permanent Resident card ("green card"), or other proof.
 Proof of Your Identity: Passport, Birth Certificate, National Identity
Document, and other documents.
 Proof of having lived in the U.S. since January 1, 2010: Rent Receipts ,
Leases, or Mortgage Payment Records; Medical Records; Employment
Records (paystubs); Bank Statements; Tax Records; Church Records;
School Records; and other documents.
Criminal and juvenile history records: If you have any arrests, go to the
courthouse and get certified copies of the final dispositions of all cases.
 Renew your passport if it is expired. Make a copy of every page of your
current passport to capture all exit and entry stamps in case your
embassy takes the old one away when it issues a new one.
